# 1. COLLECTIVE WORK OF THE REGIONAL WORKING GROUPS: POLICY & ACTIVITY HIGHLIGHTS

## 1.1 Government relations & policy advocacy

- Ongoing dialogues and consultations with the regional branches at Global Affairs Canada, in particular the Sub-Saharan Africa Branch and its Pan-Africa Bureau; the Americas Branch and its North America, Central America, Latin America & Caribbean Bureaux; and the Asia-Pacific Branch and its Southeast Asia bureau. As well, briefing meetings with Canadian diplomatic representatives in **Colombia, Guatemala, Honduras, Peru & Bolivia, and Philippines**;
- Ongoing facilitation of the RWG's perspective to Global Affairs Canada ongoing consultation on its "**Voices at Risk – Canada's Guidelines on Supporting Human Rights Defenders**";
- August 2018 | Supported the launch of the training manual "**Implementing a Human Rights -Based Approach**" with CCIC and Equitas.

## 1.2 Sector wide campaign

- Ongoing representation on behalf of CCIC and active support of the **Canadian Network on Corporate Accountability** and the campaign calling for the creation of an independent human rights Ombudsperson for Canada's international extractive sector.

## 1.3 Coalition collaboration

- April 2018 | Supported the **Women Resisting Extractivism International Gathering** in Montreal. Along many *RWG members*, *45 land defenders from over 20 countries* spoke truth to power and strategized on global resistance;



- Fall 2018 | Collaborated with **AQOCI** on three regional forums on **Latin America, Africa and Haiti** to enhance greater coordination amongst members;
- December 2018 | Supported the “Women of Courage Speak Out for Peace” delegation led by KAIROS, during the *16 Days of Activism against Gender-Based Violence*, which brought forward the voice of inspiring and courageous women from **South Sudan, Palestine, Democratic Republic of Congo, Colombia and the Philippines**.

## 2. AFRICA-CANADA FORUM (ACF)

### 2.1 Academic collaborations & learning activities

- September 2018 | Co-hosted the panel “*Challenging Africa’s Perceptions: A Feminist Perspective*” at the CCIC Annual conference with national and international speakers and journalists, and with the support of the CASID-CCIC Next Generation for collaboration and MATCH International Women’s Fund. Tackling these pressing questions were panelists Theo Sowa of the African Women’s Development fund, Gisèle Baraka Bashige, journalist and program officer at Associations des Femmes des Médias (AFEM-RDC), and Ketty Nivyabandi of the Nobel Women’s Initiative. Moderating the panel was Radio-Canada’s correspondent for Africa, Sophie Langlois;
- September 2018 | Co-organized the **South Sudan Co-Lab**, a pilot project between the ACF and Global Affairs Canada’s South Sudan

development branch. This interactive, full-day pilot “Co-Lab” was designed to facilitate a country-focused bilateral dialogue between government and civil society. In total, 9 ACF members participated and GAC staff from across the Sub-Saharan Africa branch, mainly from the International



Security and Political Affairs, Global Issues and Development branches. Participants exchanged their experiences on Canada’s collective response to the challenges in **South Sudan** from both a government and civil society perspective. [Read more here.](#)

## 2.2 Member-led Annual Meeting

- December 2018 | Organized an Annual General Meeting for ACF members with strategic discussions on policy and advocacy; key presentations focused on the situation of Human Rights defenders, in particular the rise of attacks targeting feminists and LGBTQI+ communities in Africa; and on the challenges in the field and at home of working in fragile and conflict-affected contexts. In total, **49** people participated from **34** organizations.


